TEMPORARY RESTRAINING ORDER, PRELIMINARY INJUNCTION  
28 USC 1331

COMES NOW, PATRICK J. SIMPSON, CURRENTLY IN THE SHU, SOLITARY CONFINEMENT AT THE FEDERAL MEDICAL CENTER IN LEXINGTON KENTUCKY, I FACE IMMINENT DANGER AND BODILY HARM FROM THE DEFENDANTS AT THIS INSTITUTION, I AM IN THE SHU FOR NO REASON AND THIS VIOLATES MY RIGHTS FOR CRUEL AND UNUSUAL PUNISHMENT OF THE 8TH AMENDMENT. DR. RILEY SEXUALLY ASSAULTED ME AND MY FRIEND MR. PAPAION WHILE WE WERE IN THE RDAP DRUG ABUSE PROGRAM IN OCTOBER OF LAST YEAR. DR. RILEY PERFORMED ORAL SEX ON ME IN HER OFFICE WITHOUT MY CONSENT AND SEXUALLY FONDLED ME AND TOLD ME SHE WILL KILL ME IF I TELL ANYONE, AND IM SCARED THAT THE DEFENDANTS WILL HURT ME WHILE I AM IN THE SHU. THE WARDEN HAS ALLOWED MY SEXUAL ASSUALTS AND WILL NOT INVESTIGATE THEM. I AM SO SCARED, I AM SUFFERING EMOTIONAL DISTRESS AND TRAUMA FROM THE DEFENDANTS, I SEEK IMMEDIATE TRANSFER TO ANOTHER PRISON AND TO COMPLETE MY DRUG PROGRAM SO I CAN RETURN BACK TO SOCIETY. THE DEFENDANTS VIOLATED MY CIVIL RIGHTS. AS PLAINTIFF PRAYS THAT HONORABLE COURT WILL GRANT HIS MOTIONS FOR RELIEF
